WMLEC

Field Communication Unit Cell Boosters

Raine stated that we have until June to expend the funds.

Cache Radio Batteries

That will provide 8 batteries in each county.

WMRIC

New Business

North Adams Interference

Raine stated that there are some handouts in the meeting packet concerning a frequency that North Adams is using. The frequency is affecting several other towns. The frequency is also used in Green County New York. It has turned into a political issue. The information came to the Subcommittee from Comtronics. Comtronics is proposing to change the frequency for just over \$29,000. Raine stated that it is not a qualifying expense for Homeland Security funds. The Mayor of North Adams said 911 funds can be used. Discussion followed. It was decided that no action is required unless a member from an affected town comes forward to the Subcommittee for assistance.
