Updates from the Chair

SIEC Update – Nick DaDalt reported the CMED Hovey Hill project was approved.

Project Updates

WMLEC Gap Solution – Raine reviewed the progress of the WMLEC Gap Solutions projects, and noted the Command Pod Unit was on display at the Eastern States Exposition during the Emerging Threats Training. The upgrade to the FC40 units is almost complete, and the purchase order for the Berkshire County project was issued. Steve Kozloski will provide Raine with the specifications for the Hampden County project.

CMED Hovey Hill – Raine has received the specifications for procurement, and expects the RFP to be published in the next few weeks.

Western Mass Interoperable Systems Update

Berkshire County – Jason Breault noted they are working on the radio update and the second phase of the console upgrade with Motorola.

Franklin County – Butch Garriety noted Borden Mountain and Charlemont Towers had some communication issues.

Hampshire County – None.

CMED – Bob Hassett reported the CMED projects are going well.

MSP – Butch Garriety noted the ongoing negotiations between the State 911 and the State Police Dispatchers union.

Other – Jason Breault noted that Berkshire County dispatch will start taking wireless 911 calls for the 26 towns they currently dispatch for in April.

Budget Review

Raine reviewed the FFY16 budget and expressed concerns about the WMLEC Gap Solutions project, due to delays from Motorola. Raine shared the information from the Council meeting, that MAPC and EOPSS may extend all the FFY16 contracts to December 31, 2018.

The FFY 17 projects are underway:

- ❖ COML Go Kits Raine is waiting on the specifications.
- ❖ Hampshire Hills Project: \$45,000.00 unallocated, as this project is not going forward. Raine suggested waiting until the CMED project bid is received, before committing these funds elsewhere.

Requests – Berkshire County Sheriff's Office IMT Antenna & Receiver - \$50,000.00 Jason Breault outlined his funding request to purchase and install equipment for the Berkshire County Sheriff's Office Mobile Command Center.

- IMT Nucomm CIRAS- Single Channel Tower /Truck Mounted Receiver w/integrated antenna, to replace the existing portable visa link receiver.
- IMT VMS 2000 IP Aggregator Video Management System

This would be a new purchase, separate from the current WMLEC gap solutions project. The existing Berkshire County unit is in need of repair, the cost to evaluate the unit (\$400.00) was denied at a subcommittee meeting in the past.

Raine noted that funding is not available to cover this project. There is \$45,000.00 in FFY17, and cautioned spending this money, before the CMED project is complete. Raine suggested Berkshire County should submit a request again to have the unit evaluated.

All communications units are due to be upgraded in FFY18.

It was agreed to table the request; Raine will determine if the Pittsfield Fire Department will release the unit to be evaluated, and will seek a current cost estimate.

Old Business

Helicopter Communication: - The helicopter agency did not return Bob Hassett's call; Bob agreed to follow up with EOPSS to assist in determining the frequencies used by the pilots.
