Training and Exercises: Tom asked the Council to approve the following motions:

a. NWMIMT COML Travel funds amendment

Overnight parking and hotel taxes were not included in the original request, and Tom asked for a motion to cover the additional costs of \$112.06

Motion: John Paciorek moved to approve the unanticipated costs of \$112.06 for overnight parking and hotel taxes. Carolyn Shores Ness seconded the motion. Motion passed unanimously.

b. Deerfield River Flood Tabletop Exercise :

CBRNE/IED: Raine reported that the PO's were issued for the structural collapse equipment.

Fiduciary Report:

Raine reported on flipping the FFY16 funds with FFY17 funds, and encouraged spending down the FFY16 funds.

Christine Howe reported that extensions for the FFY16 contract are being processed for two of the regions. MAPC is waiting on final written approval from EOPSS for the Central and West contracts. Christine noted the conversation around adding a school safety representative to the Council.

Old Business: Raine asked about the progress on filling the Public Health Proxy position. Nick DaDalt raised concerns about the delay in receiving the resume, and the reliability of the alternate in attending the meetings.
