Public Health Update:

The flu season is still active, with an increase in hospitalizations due to the flu and other respiratory illness. There are reports of measles cases in CT. and MA; and Washington State has reported a measles outbreak.

FFY17 Projects -

Children in Disasters Phase IV - Pediatric Surge Plan- \$50,000.00

The Council approved the project extension request at their January meeting, and Raine flipped the funds with a project that is split between FFY17 and FFY18. Tracy expects to complete the project by October 2019.

Functional/Access Needs Daily Response Planning- \$92,000.00

Stephanie Bozigian-Merrick shared they draft summary from the survey and interview results. The committee reviewed and discussed the results. Laura Kittross will provide the final notes and results from BRPC. Stephanie hopes to extend her time with PVPC to complete the project. It was agreed to also create an executive summary of the final results.

Mark Maloni's report detailed his findings on identifying a resource guide and easy to use tool for first responders to use in the field. The most suitable resource identified was from Texas A+M University. This resource provides a quick, accessible, easy to scan tool that is rich in content. The tool could possibly be adapted to create an app that meets the needs of our region.

FFY18 Projects -

Cybersecurity Planning-\$40,000.00

Hospital Regional Pediatric MCI Plan - \$25,000.00

EID Exercise Project - \$50,000.00

The WAG discussed other project ideas and revisited the idea of vaccine refrigeration for the region. The WAG will continue this discussion at their February 2019 meeting and will rewrite the proposal based on their findings.

Mental Health Recovery Resource Guide & Campaign - \$50,000.00

Public Information Message Maps - \$40,000.00

The project was originally proposed by Mary Kersell when she was still on the committee. Tracy offered to invite Mary to discuss her proposal at the next meeting.

Debris Management & SUV Online Training Reformatting - \$20,000

Review Scope of Work

Two projects of the WRHSAC, the Spontaneous Unaffiliated Volunteer (SUV) Plan Training Modules and the Disaster Debris Management Plan Template produced self- led training modules which are available through WRHSAC's website. These formats are not end-user friendly nor do they allow for engaging interaction. Through the Family Reunification Plan project, WHRSAC developed an interactive, end user training utilizing the Adobe Captivate Platform. To improve the effectiveness of the SUV and Disaster Debris Management Training, WRHSAC will transition the trainings to an interactive, online training utilizing Adobe Captivate. The project timeline is April 2019 through December 2019.

Motion: Tracy Rogers motioned to approve the Debris Management & SUV Online Training Reformatting project as presented. Larry Holmberg seconded.
