Using Large Planned **Events as Exercise & Drill Opportunities**

The Western Region Homeland Security Advisory Council's (WRHSAC) current Multi-Year Training and Exercise Plan (MYTEP) has identified large planned events as ideal opportunities to conduct inter-disciplinary drills or exercises. These events, such as the Holyoke St. Patrick's Day Parade, Mercy Sunday in Stockbridge, the Big E in W. Springfield, and the numerous fairs, multi-cultural events, races, etc. in the region, already bring many municipal, regional, and sometimes state and federal departments together in the planning and operational process.

A drill or exercise can be incorporated into an event, providing multidiscipline, multi-jurisdictional training. Planned event exercises provide an opportunity for leadership development of junior officers/officials/ staff, with senior officers/leadership providing mentorship and evaluation. Planned event drills and exercises can bring together municipal and regional resources to test interoperability. Specialty teams and personnel such as the Northwest MA Incident Management Team and region COM-L's and COM-T's can use the planned events as opportunities to complete unit-level training, sign-off on task books, and gain hours towards credentialing. These specially trained teams and personnel can also serve as mentors or evaluators. Mentorship can also be provided across jurisdictions—leadership from one agency providing mentorship to junior staff of other agencies.


WRHSAC, through its Training and Exercise subcommittee, has funding available to assist departments and municipalities in planning, conducting, and evaluating exercises held in conjunction with large planned events. Municipalities that incorporate exercises into planned events often find they enhance event coordination and operations, bring diverse participation into event coordination, and build relationships with other disciplines or departments.

Entities interested in seeking funds to conduct drills or exercises to be incorporated in large planned events should contact WRHSAC through Raine Brown, Homeland Security Program Manager at raine@frcog.org or 413.774.3167 x138. Entities should allow at least six months, ideally nine months, lead-time before the planned event to apply.

Cybersecurity Awareness Training for Municipal Officials

WRHSAC, in partnership with the other Massachusetts Regional Homeland Security Advisory Councils – Central, Southeast and Northeast – created a Cybersecurity Awareness Training Series for Municipal Officials. The series consists of six online learning modules built on the Department of Homeland Security, Cybersecurity and Infrastructure Security Agency's (DHS/CISA) Cyber Essentials Toolkit.



The online learning modules lead municipal officials through the basic steps of a holistic approach to create a cyber-secure environment. Each module focuses on a specific area, Yourself, Your Staff, Your Systems, Your Surroundings, Your Data, and Your Actions Under Stress, which together help you to build a culture of cyber readiness. The modules are self-paced and are each approximately 10 minutes in length and are available to access anytime.

Two webinars accompanied the series launch during National Cybersecurity Awareness Month, October 2020. In the webinars, subject matter experts delved more deeply into the module topics and answered participants' questions. The webinars were recorded and are available on WRHSAC's website.

WRHSAC's First Responder Mental Health Resiliency -Phase I

WRHSAC is proud to announce the first phase of its <u>First</u> <u>Responder Mental Health Resiliency</u> project. This first phase is a training focused on supporting first responder leadership to create positive mental health work environments.

The training is **Building Healthy Workplaces: How to promote mental health in first responder organizations**. The training includes two parts: an online, self-paced introduction followed by a more comprehensive interactive, virtual, four-session series.



The Introduction to Building Healthy Workplaces provides the basis to support informed dialogue and participation during the more in-depth virtual series. The Introduction is available via WRHSAC's new online learning management system at www.learning.wrhsac.org/courses. The training is free and accessible after a simple registration process. Follow the links on the page.

The second part of the training, Building Healthy Workplaces, offers deeper discussion and planning to support first responder leadership towards promoting positive mental wellbeing within their organizations. Delivered as a four-session series, the training will be conducted over four consecutive weeks via Zoom 'live' online on the following dates in 2021: January 22, 29, February 5, 12 (all sessions 10 a.m. to noon). The training is free.

Participation in Building Healthy Workplaces is prioritized for first responder leadership in Western Massachusetts. <u>Submitted applications</u> will be reviewed to ensure participants are in a leadership role. Attendance at all four sessions is recommended. This is an interactive training and access to audio and visual capabilities are required.

The introduction training is a prerequisite for participating in the Building Healthy Workplaces four-session series.

PROJECT HISTORY

WRHSAC recognizes that the greatest assets in any first responder organization are first responders themselves. First responders encounter stressful situations on a daily basis. Their experiences of potentially traumatic incidents are greater than those seen in most other occupations. This reality places tremendous stress on the nervous system and overall health of team members.

In early 2019, WRHSAC embarked on a First Responder Mental Health Resiliency project. Conversations with regional stakeholders and research on available best practices led WRHSAC to determine that a program to assist leadership in developing and fostering positive mental health work environments would be key to building individual and team mental health resiliency.

WRHSAC's approach is modeled on British Columbia, Canada's WorkSafeBC <u>First Responders' Mental Health Committee</u>. WRHSAC engaged two mental health clinicians familiar with the unique concerns of first responders to engage with the WorkSafeBC project and to adapt it to the needs of Western Massachusetts first responder agencies. As experienced mental health clinicians, our facilitators Calla Harrington LCSW, MSW, MPH and Lillian Lennox LMHC, MA, C-iRest, E-RYT 500 bring important mental health definitions, concepts and offer a multidisciplinary approach drawing from many perspectives.

Members of the BC First Responder Mental Health Committee have made our team aware of their upcoming (January through March 2021) webinar series BC First Responders' Mental Health Speaker Series: Leadership for the Mental Health of your Workplace and have extended an invitation to our region's first responder leaders to attend. The series will focus on actively developing the knowledge and skills of first responders in leadership positions, so they can take a proactive approach to promoting positive mental health in their organizations. The Western Region Homeland Security Advisory Council (WRHSAC)
