Vehicle Stabilization and Lift Training

Limited Spaces Available

We've had several cancelations, so registration is again open for this training.

Many fire departments may not be prepared to respond to the challenges presented by large commercial vehicle accidents, such as a tractor trailer or tanker rollover. The amount of equipment and personnel necessary to handle these types of accidents could easily overwhelm a department.

Stabilizing, lifting and capturing are three vital components associated with a successful rescue operation when dealing with a confirmed vehicle pin. Remove any one of these, and the results could be disastrous for the victim and rescuers.

Vehicle Stabilization and Lift Training for First Responders will help participants to understand the risks inherent in a vehicle rollover and pinning, and provide the skills to be able to lay out a plan of response and implement it.

This two-day training is being held in Northampton on Tuesday & Wednesday, April 19 & 20.

WRHSAC is conducting an After Action Review of the region's COVID-19 response. A consultant has been hired. Information will be gathered via survey, one-on-one interviews, at standing meetings and through focus groups.

If you are contacted by <u>Day Health Strategies</u> on behalf of WRHSAC, we sincerely appreciate your participation in helping us to capture a board and deep view of the region's response to COVID-19.

An After Action Review Conference will be held in late fall 2022 to present the findings. WRHSAC will utilize the outcome and recommendations to help direct funding over the next several years.
